

TERMS AND CONDITIONS

"March into Eat Street"

PROMOTION

1. Information on how to claim and gifts form part of these Terms and Conditions. Participation in this "March into Eat Street" ("Promotion") is deemed acceptance of these Terms and Conditions.

ELIGIBILITY

2. Subject to condition 3, this Promotion is only open to Australian residents. 3. The following are ineligible: (i) employees of the Promoter or any of the tenants or retailers or their staff at Burwood Brickworks or any of the Promoter's agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

PROMOTION PERIOD

3. This Promotion commences at 12.00pm Australian Eastern Daylight Savings Time ("AEDT") on 18 March 2021 and ends at 8.00pm AEDT on 28 March 2021, or when maximum promotion value has been reached, whichever occurs first during the ("Promotion Period").

HOW TO CLAIM

4. The Promotion will be conducted at Burwood Brickworks ("Participating Centre") 5. To be eligible to participate in this Promotion and receive a \$10 'main' dish, \$5 kids meal or \$5 dessert, participants must dine in between the hours of 12.00pm and 2.00pm and 5.00pm and 8.00pm during the "Promotion Period". Dine in only (exclude acre Cake & Counter and Ben & Jerrys). 'Main dish', 'kids meal' and 'dessert' are subject the menu items chosen by individual retailer.

GIFTS

6. Subject to the availability of gifts and any limits imposed on the number of gifts that can be claimed by an individual as set out in these Terms and Conditions, each valid claim submitted to participating retailers at Burwood Brickworks Shopping Centre in accordance with these Terms and Conditions will be able to receive one price reduced meal item per day per person. 8. The total redemption pool amount is \$19,000.00 AUD.

GENERAL

7. Each individual is only permitted to make one (1) gift claim per meal under this Promotion. Incomplete, indecipherable or illegible claims will be deemed invalid. Any gifts that remain left over at the conclusion of the Promotion Period will remain the property of the Promoter. 8. The Promoter reserves the right, at any time, to verify the validity of claims (including contacting Participating Retailers) and claimants (including a claimant's identity, age and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. 9. If there is a dispute as to the identity of a claimant, the Promoter reserves the right, in its sole discretion, to determine the identity of the claimant. 10. If the gift is unavailable due to reasons beyond the control of the Promoter, the Promoter in its discretion, reserves the right to substitute the gift with a gift of the equal value and/or specification, subject to any written directions from a regulatory authority. 11. Total value of gifts to be provided under this Promotion is up to \$19,000. Gifts, or any unused portion of a gift, are not transferable or exchangeable and cannot be taken as cash, unless otherwise specified. 12. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any claimant; or (b) subject to any written directions from a regulatory authority to modify, suspend, terminate or cancel the Promotion, as appropriate. 13. The Promoter's decision is final and no correspondence will be entered into. 14. Nothing in these Terms and Conditions limit, exclude or purports to limit, exclude or modify the statutory implied guarantees/warranties as provided under the Trade Practices Act, ASIC Act, or the Competition and Consumer Act including the guarantees under the Australian Consumer Law or similar laws in the State and Territories of Australia ("Non Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter and Frasers Property Pty Ltd (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion. 15. Except for any liability that cannot by law be excluded, including the Non Excludable Guarantees, the Promoter and Frasers Property Pty Ltd (including their respective officers, employees and agents) are not responsible for and exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any claim or correspondence that is late, lost, altered, damaged or misdirected (whether received by the Promoter or not) due to any reason beyond the reasonable control of the Promoter; (d) any variation in the gift value to that stated in these Terms and Conditions; (e) any tax liability incurred by a claimant; or (f) use of a gift.
